

The São Paulo Symphony Orchestra Foundation - Osesp Foundation - invites applications for the vacancy of **PRINCIPAL VIOLA – Category I**.

## 1. Remuneration

Gross monthly remuneration:

Salary of R\$ 25,524.40 (twenty-five thousand, five hundred and twenty-four Brazilian reais and forty cents), including aid for instrument maintenance of R\$ 1,160.20 (one thousand, one hundred and sixty Brazilian reais and twenty cents), and copyrights and authorization for publication and dissemination of image of R\$ 1,160.20 (one thousand, one hundred and sixty Brazilian reais).

- Terms of employment following the federal labor laws (CLT); 13<sup>th</sup> month salary; paid vacation; FGTS Length of Service Guarantee Fund.
- Health insurance; Dental Plan; Group life insurance; Private pension.
- Child day-care assistance (under Osesp Foundation's internal contract policy).
- Payroll loan.
- Car parking at the Sala São Paulo venue.
- Monthly meal, transportation, and cultural voucher.
- SESC partnership services offered in many areas, such as health, leisure, culture, education, sport, tourism, and sustainability.

## 3. Local of the Auditions

The audition will be held at Complexo Cultural Júlio Prestes – Sala São Paulo (Praça Júlio Prestes, 16, São Paulo - SP). Candidates are responsible for costs referred to their participation in the audition, including transfers, accommodation, and any other expense.

## 4. Schedule

The schedule of auditions will be notified individually to each candidate after the conclusion of the "First Phase" of the selection process.

## 5. Applications

Applications will be accepted by email only between April 26<sup>th</sup> to May 22<sup>nd</sup>, 2024.

# 6. SELECTION PROCESS

## First Phase

Candidates should send their CV, completed <u>registration form</u>, and video recording<sup>\*</sup>, via email, for the attention of the Artistic Department of Osesp Foundation. After the CV analyzes, may be requested some additional material, including concert programs, letters of recommendation, and other documentary evidence. For the following phases of the audition process, only candidates whose profile is considered suitable by the Examining Board.





\*The repertoire requested for video recording is: the exposition of the first movement with cadence of one of the Viola concertos to choose between Stamitz or Hoffmeister; and also, two contrasting movements from a Bach *Suite* (except *Suite N. 1*). Preferably with piano accompaniment. Only recordings sent via YouTube via open link, Dropbox or other commonly used method will be accepted.

The list of candidates approved on the First Phase will be available on May 28<sup>th</sup>, 2024, at Osesp website: <u>www.osesp.art.br</u>. Candidates will also be individually notified by email.

## Second Phase (June 28<sup>th</sup>, 2024)

Candidates selected in the first phase will be invited to participate in an audition before the OSESP Examining Board made up of the OSESP Musical and Artistic Director and the OSESP section leaders. This stage can be eliminatory or qualifying, at the discretion of the Examining Board.

Osesp Foundation will make available a pianist to accompany candidates on the audition day. Candidates may also opt to carry out the audition with their own pianist.

#### Third Phase (an optional phase)

If required by the Osesp's Music Director Thierry Fischer, selected candidates will be invited to perform for one or two weeks with the orchestra, on programs conducted by Mr. Fischer - on dates to be determined - and with remuneration for the respective weeks.

#### 7. General Conditions

The successful candidate will be subject to a probation period with the São Paulo Symphony Orchestra of up to two years.

Osesp Foundation will provide the successful candidate with all information relating to the terms of employment, legal formalities, and documentation needed to employ Brazilian or foreign musicians.

In the case of foreigners not residing in Brazil, OSESP Foundation will be responsible for applying for the suitable visa to work in Brazil, as well as for a residence permit, and the approved candidate must pay the costs for issuing and sending all necessary documentation for these applications.

All communication between Osesp Foundation and the candidates will be carried out and documented via email.
